Great Results at the 2004 Junior Olympic National Championship Matches

This year's match results are not final as we prepare this issue for publication. However, we do have some Air Rifle and Pistol results for you. This match is the toughest match that any young shooter will attend in the USA. The competition is intense. Only those shooters who are fully prepared will rise to the top to shoot their best or even their average practice and match scores. Just securing an invitation to the Championships is a significant achievement and a sign of excellent potential. Kaylee, Chris, Matthew and Levi can all hold their heads up high. They each worked hard to fire each shot to the best of their ability, and they all learned again that the value of perfect and regular practice cannot be overstated.

Eric has offered to submit a more complete article of the Junior Olympic matches for our next issue, and we look forward to that. The results are available at USA Shooting's <http://www.usashooting.com/results/Results.cfm> website. We recommend that you all check them to see just how well our USA junior shooters can shoot in a high caliber match like this one. The level of competition is much higher each year. The results for our shooters are as follows:

Women's Air Rifle - Kaylee Kuntz fired a 359 the first day followed by a 361 the second day for a total of 1120 and an average of 90%.

Men's Air Pistol - Chris Pueppke fired a 502 the first day followed by a 513 the next day for a total of 1015 and an average of 84.6%.

Men's Air Rifle - Levi Geurts fired a fine 583 the first day followed by a personal best of 587 the second day for a total of 1170 (97.5%). This aggregate placed Levi in the Final 8 where Levi fired a 101.9 to close out in 6th place overall.

Matthew Pueppke fired a personal best of 570 the first day followed by a fine 563 on the second day for a total of 1133 (94.4%). This Aggregate won the Silver Medal for Matthew as a J3 shooter.

The Smallbore matches follow for Levi, so he still has another few days to enjoy the matches. When you next see these young people, extend your congratulations.

The Values of Competitive Shooting

Scott Pilkington wrote a great article in the January/February issue of the USA Shooting News about the benefits competitive shooting offers to young people around the nation. For those of you who do not subscribe to USA Shooting News, I rephrase some of his points here as follows:

1. Because successful competitive shooters must learn self discipline, self management, problem solving and emotional control, they are well on the way to being adults.
2. The shooting sports offer equal opportunity to young and old of large or small stature. Young men and women compete together equally. Young people, who do not have the stature required in other sports, often excel in the shooting sports. Children, their parents and often their grandparents compete on an equal footing.
3. Air rifle shooting is one of the fastest growing youth sports. High schools in 45 states offer air rifle as a varsity sport. Many high school air rifle shooters are eligible for NCAA scholarships at 56 colleges around the USA. Additionally, 78 colleges have rifle, pistol or shotgun shooting as an intramural club sport.
4. A motivated team can go places. Dan Geurts and his Buffalo, ND junior BB gun and air rifle shooters are a perfect example of the opportunities available for team travel around the USA. Those young people who shoot well enough to make the US Shooting Team will compete around the world.
5. The shooting sports offer young people with low self-esteem the opportunity to discover their own self worth.
6. When Nancy Johnson won the Olympic Gold Medal in the Games of 2000, the whole world was watching and people across the USA were cheering her accomplishment.
7. The CMP tracks data from over 2000 high school teams and 1000 junior clubs to find that there is not a single injury that involved a shooting accident. This means that shooting is one of, if not THE safest of school sports.

The clubs will need a continued commitment from their members to volunteer their time as range officers and janitors and educators over the years ahead in order to realize the potential these facilities offer to their local communities and to the State of North Dakota.

In fact, I have no response to my challenge at all. I will continue this challenge until our next issue to see if we receive anything to print. Junior Olympic Selection Match 2004

The North Dakota State Junior Olympic Selection Match held at the Lake Region Shooting Sports Association range in Devils Lake on January 11, 2004 was another success. Our match winners have each fired scores that exceed USA Shooting requirements for invitation to the 2004 Junior Olympic National Championships. **Thanks again to all of you who competed in the match.** A match like this one requires a great deal of time and effort by volunteers from our state's shooting clubs as well as the shooters' parents and the coaches. I believe that each of these volunteers find reward for their efforts to be the generally excellent effort put forth by the competitors themselves. It is a great pleasure to any volunteer to see their efforts produce a good result, and we certainly have good results to report here again this year.

We congratulate our winners for some very fine scores. Levi's air rifle score of 577 is a hard 2 points better than his 2003 qualifying score. Matthew Pueppke once again fired an Open Qualifying J3 score with his air rifle. Ryan added 9 points to his 497 from last year for a 506 and the bronze medal.

The Junior Women's Air Rifle performance is also an improvement over last year's. Kaylee Kuntz fired a 356 last year and added 8 points for a 364 this year. Kelsey Carlrud added a full 100 points to her score last year for a 334 this year!

The Smallbore results are a real improvement as well and quite impressive. The most obvious improvement is in the women's category where Kaylee Kuntz added a full **59 points** to her last year's score with her gold medal performance of 517. Levi's 580 is a full 38 points better than his last year's score. Darren Dyk added 102 points to his 2003 score to take the bronze medal. Our other returning shooters from last year's JOSOC similarly improved their performances.

Our winners received an invitation from USA Shooting to participate in the 2004 Junior Olympic National Championships at the Olympic Training Center in Colorado Springs. Good luck to:

1. Smallbore Rifle-State Qualifier-Levi Geurts
2. Air Pistol-State Qualifier-Chris Pueppke
3. Air Rifle-Men's State Qualifier-Levi Geurts
Men's Open Qualifier-Matthew Pueppke
Women's State Qualifier-Kaylee Kuntz.

We congratulate the efforts of these young people and their coaches.

Great junior 4P matches this past weekend. Levi Guerts fired a 100-9x standing (100-10x possible) in the North Dakota State Championship match on Saturday. Needless to say this is a new state record and will probably be one for many years to come. By the way - he did set a record in standing last year with a 99/100. He finished with a 393/400 in the state match -

not bad - but he needs to work a bit on that sitting (dropped 5 points).

The Sectional was fired on Sunday - Kaylee Kuntz fired a 390/400 - to put a little heat on Levi. She closed out the match with a 100-8x kneeling score. Needless to say that is also a new state record besting Greg Erickson's (I believe from Minot) 100-6x set way back in April, 1987. Also she pounded out the score in about 5 minutes with about 7 or 8 sighters. When you're in the middle in kneeling - go for it. However, it almost didn't stand when Levi fired a 99-9x in kneeling on the next relay. Levi took the gold in the Sectional with a 394/400. Good score and it should place him fairly high in the national tournament - but someone always shoots a 399 or 400 in this match. Those kids can shoot.

Overall it was a good tournament - need a few more shooters from Grand Forks and Minot - which I sure will be coming with the new ranges going up.

Until we see each one of you again, remember to take enough time to enjoy your success during the match. You only control one shot at a time, so put your best effort into that individual shot to shoot one 10 at a time. When you do shoot that 10, be sure to pause long enough to savor it for a little while before going on to shoot the next one.

2003 Camp Perry Report (Highpower phase)

The 95th year of the National Matches is in the books and it was a record setting year. This years contingent of North Dakotan's included yours truly - Tom Thompson (Bismarck), Dennis Coulter, William O'Connell, Tom Reiten and Charlie Christenson (all from Grand Forks), Coby Dalgliesh (Sarles), Andy Johnson (Rolla) and we were also joined by Tony Kozojed from Thief River Falls, MN. Dan Marquart from Bismarck also fired with the All Guard Team in the Service Rifle portion of the National Matches this year; however, he was unable to fire in the NRA Championship. Dan did post a great score in the National Trophy Individual Match or Leg Match firing a 491-20x (500 possible); good enough for 15th place of 1280 shooters.

There has been quite a feeling of nostalgia at the matches over the past few years, and as a result, the Civilian Marksmanship Program (CMP) has added a couple of fun matches. The first of which was the Garand Match, added in 1998 in honor of John C. Garand - inventor of the M1 Garand rifle. In 2002 the CMP added the Springfield Match. By the way, Jim Barner (Emerado, ND - not with us this year) was the winner of the inaugural Springfield Match fired last year. Jim fired a score of 293 over the 300 point course. These matches also seem to have a side benefit in that they may have increased the attendance at the Service Rifle matches.

Format for these matches is simple - 5 sighters prone, then 30 shots for record, 10 prone, 10 rapid fire prone (10 shots in 70 seconds) and 10 shots standing. All firing is from the 200 yard line, and all shots are taken in succession - once you're on the line - you fire the complete course. Awards are predetermined based on score and everyone that fires the match receives a t-shirt. Ammunition is also supplied. The Garand match, as the name implies, can be fired with the M1 Garand. However, any U.S. military arm before the Garand can also be used (i.e. Springfield, Carbine, Enfield, etc. - no not the 1873 trapdoor Springfield). In the Springfield Match, any military bolt action arm can be used.

The Springfield Match was fired on Friday, August 8. Coby, Andy and Tony fired the Springfield Match this year. Coby was the top shooter from North Dakota firing a 277-4x, good enough for 34th out of 540 competitors in the match. The John Garand Match was fired on Saturday, August 9. This year 1236 competitors fired the match. This "nostalgia" match has grown to be one of the most popular matches during the National Matches. Coby, Andy, Tony and Tom Thompson fired the Garand Match. Tom was the high NoDaker firing a 285-7x, which was good enough for 15th place.

On Sunday, we fired the Rumbold Team Match which consists of 4 firing members and 50 shots for record for each shooter. Well, Team Roughriders and Team Easyriders will have to wait till next year to make their mark. We fired well, but didn't finish in the money.

Monday, August 11, 2003, was the start of the National Championship Match. The course of fire for the Individual National Championship matches is 240 shots for record over 4 days for a 2400 point possible score. The weather was the usual for August in Ohio. If you've ever been to Ohio - you know what I mean; hot days with lots of humidity. We didn't have the wind like last year (on days 2 and 3). However, we did have intermittent rain and wind on Day 2. On Day 2 this year, the wind was up as the first 2 relays fired their offhand. But the wind laid down just enough for the High Master relay to post some respectable scores. By the end of Day 2, it was becoming obvious that some spectacular final scores would be posted - if the conditions held. By the end of Day 3 - the perennial Champion David Tubb was down only 10 points. Right behind

him was Norman Houle (West Warwick, RI) who was down 11 points. Day 4 - Tubb turned on the heat and Houle faded (if one could say that). Tubb fired a 799-50x to set a new national record for the final aggregate match, dropping only 1 point in the final offhand match. Houle fired a 793-41x in the final aggregate. Tubb won his 11th National Highpower Championship dropping only 11 points for an incredible 2389-138x (that's an average better than a 796 per 80 shot match!) This is the new national match record surpassing the 2385-101x set in 1992 by Carl Bernosky of Ashland, PA. Houle fired a 2385-117x for second place (this score would have also been a new national match record). Third went to John Harrison (Westminster, MD) with a 2377-95x.

There were no big scores posted by the North Dakota team this year. However, Tony Kozojed did fire a 199-13x which was High Senior in the Appreciation Cup (200 yard rapid fire match). Someone always seems to post at least one notable score. James Fox, a junior from White City, OR, fired a 200-8x clean in the Members Trophy Match. This is the first **OFFHAND** match of the championship. Then there's the junior champion, Scott Roberts from Honey Brook, PA, who fired a 2362-105x good enough for 14th place overall in the championship. This is a huge score for a kid that isn't even 20 years old yet. However, then there's Scott's little brother, Calvin Roberts, who won the Intermediate Junior championship with a score of..... (Are you ready for this)... 2372-113x and good enough for 8th place overall. This kid's not even 17 years old yet.

The 2003 Long Range Championship began on Friday, August 15. The first day of Long Range is 3x600 yard matches. The weather was good in the morning, but rain cancelled the last 600 yard match. Michelle Gallagher fired a 200-17x for the win in Match No. 1, and Michelle Maxberry hammered a 200-18x for the top spot in match No. 2.

Day 2 of the Long Range event is the Leech Cup. Nancy Tompkins-Gallagher fired a 199-14x and then a 97-4x in the shoot-off for the win. Day 3 of long range is the Wimbledon Cup match. Norman Crawford fired a 200-11x and then a 99-5x in the shoot off for the win. The final day of the National Long Range Championship is the Palma Match. Nancy prevailed again firing a 448-28x for first place. Nancy won the 2003 National Long Range Championship firing a 1241-76x of a possible 1250.

It's always interesting to see the new and innovative equipment shooters are using at the national matches. AR-15's have just about totally replaced the venerable M14 in the Service Rifle class and space guns (highly modified AR's) have just about replaced the bolt guns. The .223 is becoming a very popular cartridge for this game. And with the advent of the heavy VLD bullets, such as the 80 grain Sierra Match King, this cartridge stays very close to the bigger calibers at the 600 yard line and just about out shoots everything at the 200 and 300 yard lines. To make things even more interesting, JLK (Jimmy Knox) has developed a 90 grain bullet for the little .223. Shooters are firing this bullet in 3 grooves, 6.5 inch twist PacNor barrels. During the match I was shooting next to German (pronounced Herman) Salazar from Florida. In one 600 yard match, German was inside my wind by 1 ½ minutes (I was using 4 minutes of wind to his 2 ½ minutes - interesting).

Tubb is into his 3rd year with the Tubb 2000 rifle. This is a bolt action rifle. However, similarities to a standard bolt action rifle stop here. The rifle is all aluminum and steel (no wood). The action is situated low in the stock so that the bolt can run below the shooter's cheek, making it possible for the shooter to keep his cheek on the stock during rapid fire strings.

If interested, this rifle will run you around \$3000. There was also a Tubb alternative being developed by several shooters from Indiana. This firearm uses your Remington medium action glued into a steel and aluminum tube. Check out MAK Enterprises on the internet. Currently, they have a single shot model and they are in development of a repeater. Cost is in the \$650 range. The concept is the same as the Tubb gun - mount the action low so the bolt runs below the shooter's cheek.

This game has seemed to center on the 6mm caliber, and various wildcats in 6mm continue to show up on the range. Last year Tubb was using the 6x which can be made using a standard .243 reamer and then hold the reamer 0.130" short while chambering. Cases for the 6X can be fire formed from .22-250 cases. This year Tubb was back with an improved 6X which included a 30 degree shoulder - hence the 6XC. Randy Gregory from Medford, Wisconsin, has also developed a popular wildcat round. His development is the 240NMC which is also fire formed from .22-250 cases. Several shooters from the cheese state and also Minnesota were focused on that round. The chase for the accurate caliber and firearm never ends.

Well, that's it for Perry 2003 and yes, we are planning to take a full team to Perry for 2004. After all, we have to keep going back until everyone (or someone) gets it right. If interested, give us Highpower shooters a call and we'll make room for you on the 2004 team.
